

SIXTH ITF ANNUAL CONSULTATION ON GENDER AND TRANSPORT WEDNESDAY 19 JANUARY 2022, 14.00 – 16.00 CET (via Zoom)

Context

Since 2016, the Annual Consultation on Gender and Transport has been a platform for the International Transport Forum (ITF) and its stakeholders to exchange on how questions related to gender equality in transport can be addressed in the ITF Annual Summit programme. The meeting also serves as a forum for sharing best practices and insights with regard to gender and transport issues more broadly.

The upcoming 2022 ITF Summit on *Transport for Inclusive Societies* will highlight current and emerging issues relevant to inclusive transport, including the physical and social dimensions of accessibility and promoting resilience and equity within the transport labour market. The context of the COVID-19 pandemic crisis and recovery measures will feature prominently in the discussions as various sessions will consider the disproportionate impact of transport and mobility-related disruptions on society's most vulnerable groups and communities.

The 2022 ITF Annual Consultation Day with International Organisations, to be held back-to-back with the Consultation on Gender on 20 January 2022), will provide an opportunity for international organisations to discuss how their policy priorities, including with regard to gender and transport, relate to the 2022 Summit theme.

The 2022 Consultation on Gender will focus on the ITF's current work on the development of a *Gender Analysis Toolkit for Transport Policies*.

Objectives and thematic scope

The ITF is expanding its work in the area of gender in transport and is developing a new gender analysis toolkit for transport policies for its member countries and beyond. The Toolkit aims to provide guidance on how to conduct gender analysis for transport policies, as well as to support the development of a gender policy dialogue. It also includes the identification of gender-relevant data and indicators and a review of data collection processes.

The Consultation on Gender will be an opportunity for the ITF to share with its key stakeholders a preliminary draft of the Toolkit and to exchange insights on the topic of gender analysis for transport policies and projects with all stakeholders.
